# Junior League Report:

Frank Weber advised that with the trials approaching it has been decided that suspended players are not allowed to participate in trial matches.

They will receive a concession that the two official Junior League trial matches will count towards their suspension.

During the trials sin binned or sent off players can be replaced by the coaches and that the referees are not to call time to pull the players off the field.

Judiciary for 2014 will have its first night prior to the season commencing will be on the 23<sup>rd</sup> April for players who do not take the early guilty plea during the trial matches.

There will be some minor changes with regards to the points system seeing a difference of 600 points between a Grade 1 and a Grade 2 charge.

St Clair has asked the Junior League to share their concerns with regards to "grass cutting / ankle tackles". Phil Haines defined this as a 3<sup>rd</sup> man. Brett Lynch advised that this will be based on the NRL and NSW level of a 3<sup>rd</sup> man in tackle having to be above the knee for initial point of contact

## Director of Coaching and Development Officer: Gary Haines

Level 1 face-to-face course will be held on Saturday 15 March at Sportingbet Stadium commencing at 9am. All candidates must register for the course at <a href="www.playrugbyleague.com.au/referee">www.playrugbyleague.com.au/referee</a> and complete the online tutorials.

Training commences on Tuesday 11 March at Jamison Park No 5. All active referees are encouraged to attend training.

A CMO course will be held at Sydney Olympic Park on Tuesday night 25 February commencing at 7pm. The course will provide an overview of the structure for recruiting of referees.

Members wishing to do the level 2 course should advise me as soon as possible as the NRAS Manager is planning to conduct a course shortly. Details will be provided as soon as they are known.

Interpretation Guidelines to assist clubs with referees' rulings will be prepared and made available to the Junior League. For example, Shoulder Charge: will be penalised when a defending player does not make a genuine attempt to tackle the man in possession; 10m: will be measured from the centre of the ruck. When the PTB is taking place on a line of demarcation, the referee will mark the 10m at the next line.

The level 1 course will be held on 15/03/2014 at the Hunter Room at Panthers. Advised that training will commence 05/03/2014 at Jamison Park number 5 CMO course will be held on 25/02/2014 at 7:00pm

Doug Keen has advised that the level 2 course will be held at Homebush on 16/03/2014 all referees wanting to participate are to email their request to Gary.

John Woods and Gary Haines will be meeting prior to the season commencing to have the interpretation guidelines completed with a copy being sent to Yvonne Purtell.

The advisory board will be having a meeting with Gary prior to the season commencing to go through how they are to assess the referees for their reports. Gary Haines will advise of the date shortly.

## **Board of Management Report: Sarah Ford**

Brett Lynch congratulated Rohan Best for being selected into the Graded Squad. Rohan is the 32<sup>nd</sup> Penrith Referee to make grade since the Association was formed. Brett acknowledged Reg Newsom for having founded the Graded Squad to which Reg thanked Brett. Brett advised the members that since he made Grade in 1995 16 members have since been graded.

Brett advised that all of the Sydney Presidents met a few weeks ago and that you can now become a referee from the age of 13, however, you can only referee non-competitive games and touch judge up to mod level until you turn 14 and this is NRAs policy Australia wide.

Don Courts asked that all shirts still to be handed out to life members be sent out. Phil Haines advised that he is in the process of getting the shirts form Rickey McFarlane and will be posting them out to the life members. Brett Lynch advised that this was addressed at the last BOM meeting and was organised for Phil to send them.
